MEETING OF PUBLIC AND INVITATION FOR DISCUSSION

<u>Michael Leibruder, 84 Summit Avenue</u>, appeared before the Mayor and Council to ask what steps were being taken regarding the discoloration of his water, as the problem seems to have escalated. According to Mr. Leibruder, flushing seems to help but it is not consistent and filters are expensive. Mr. Lampmann stated that the pipes were scheduled to be flushed again on April 20, 2011; additionally a polymer is being added at the treatment plant and that takes approximately one and a half to two months to bond with the pipes. Mayor Alviene reiterated that steps are being taken to alleviate the problem. Councilman Verdonik noted that the liquid feed of chemicals would take time to bond with the pipes. Mr. Leibruder asked if he could be updated on the on the progress with the polymer. Mr. Lampmann explained that testing would be done to ensure the proper chemical compound is used to deal with this issue.

<u>Deborah Sammon, 80 Summit Avenue</u>, has not experienced the same issues as Mr. Leibruder; however, she uses less water. She wanted to clarification that the flushing will be done exclusively on Monday through Friday.

Council President Vath reported on the following:

Budget to be introduced this evening will increase taxes \$97.31, on the average home, which is assessed at \$252,702. The increase is minimal while staying within the 2% CAP. The Board of Health appointed the Borough Clerk to the position of Borough Registrar. John Theese is no longer the Health Officer for Madison, Mr. Lampmann will check to see who is replacing Mr. Theese. The Health Department conducted a Safe Serve program for the Little League

Mayor Alviene thanked the Council and Administration for all the hard work that was done to keep the budget under the CAP.

Councilman Fox reported on the following:

The Kakeout Road Improvements Bid opening was earlier today, Mike Fitzpatrick and Son being the low bidder; the bid is on the agenda for award later on this evening. These improvements are using grant monies the Borough has received. Construction is scheduled for approximately one month from now, with paving being done right after July 4.

Councilman Verdonik reported on the following:

Water and Wastewater flushing is being done; locations and dates are posted on the Borough Website. To reiterate the polymer is being added to alleviate the water discoloration issue on Summit Avenue. Maintenance is performed on a routine basis.

Councilman Meier reported on the following:

The electric utility has completed tree trimming for the year with Cutlass and Woodland Road. Merberry Lane changes were done in conjunction with Verizon raising lines. Equipment upgrades to primary fault indicators making it easier to locate faults. A fault wizard was purchased to minimize the area disturbed when locating underground cables. Additionally, work was performed on Carey Avenue and Decker Avenue in Butler. A tree was removed in Bloomingdale, meters were read and a pole was replaced in Riverdale.

Councilwoman Woop reported on the following:

Clean communities will do a cleanup prior to the commencement of the Market on Main Street, various neighborhood groups are being contacted to plant flowers. Anyone interested please get in touch via the Butler Business Association Website.
