## MEETING OF PUBLIC AND INVITATION FOR DISCUSSION

Mayor Martinez performed the ceremonial swearing in of Officer Lauren Parak.

Mayor Martinez then honored the Butler All Conference Athletes and Butler Running Club members and presented them with certificates.

Mayor Martinez opened the meeting to the public.

Frank Blatterman from 46 Maple Lake Road approached and inquired how many lanes the temporary bridge on Rt. 23 would be. Mr. Lampmann explained we wrote a letter supporting the newly proposed 4 lane temporary bridge and anticipates that being the design. He then asked if we would place a sign on Maple Lake Road that reads "Entering Butler" because after receiving a package for 46 Maple Lake Road, Kinnelon, the UPS driver told him they do not know where Butler ends and Kinnelon starts. He thinks this would relieve a lot of the confusion.

Tom Figura from 47 Roosevelt Ave approached and stated his concerns over the recent spike in taxes again. He wanted to know if during the reassessment over the next 2 years if it is going to continue going up? Council President Verdonik said the valuation went up but it doesn't necessarily mean you're going to pay more. He also explained that only approximately 22% comes to the Borough with the majority going to the Board of Ed and the County. Mr. Lampmann also explained that the increase does not generate any additional revenue for the Borough when the values go up. He did explain that the recently passed BOE referendum may increase the taxes. Mr. Figura said he believes the values are too high. Mr. Lampmann reminded him of his right to appeal.

Szymon Jedryczka from 72 Spring St. approached and also expressed his displeasure in the taxes going up every year. He said every year his home value goes up 40-60k. Wants to know when it's going to stop? Councilman Calvi stated we are all in the same boat.

<u>Councilwoman Morley</u> reported on all satisfactory and conditional inspections. Blood pressure clinic was attended by 9 people.

<u>Councilman Calvi</u> stated we had 19 MV accidents with 14 considered reportable and 6 injuries. Three DUI arrests. 183 summonses were issued from 277 stops. 8,275 random license plates checks were processed. There were 7 arrests for a variety of criminal offenses. He welcomed newly sworn-in officer Lauren Parak. He also reported that the BPD attended the County College of Morris Law Enforcement Career Fair and also assisted Aaron Decker School with a safety drill. 16 firearm applications were processed.

<u>Councilman Meier</u> reported tree trimming on Macopin Rd. and associated side streets. Crews installed holiday decorations including a new LED train display. All truck rubber, rubber gloves and sleeves were switched out per OSHA requirements. BP&L received delivery of 40' and 45' poles. Crews performed a service upgrade at Richard Butler School. Poles were set in multiple locations in preparation for Planet Networks installation of the new fiber system throughout our territory. Poles were also installed along Route 23 for the NJ Guardrail Improvement Project.
