Discussion – Butler Day – Mayor Martinez said they had a zoom call with JamFam Productions. Stated they would handle the acquisition/promotion of vendors but all the extras (food trucks, rides, etc.) would be the responsibility of the town. Councilman Fox expressed his concern over the funds needed to complete road paving and that should be more of a priority than doing Butler Day. The Mayor confirmed they will not run it through the Rec. Dept like they have in the past, it will be through the Borough. Councilman Calvi wants to see prices! Councilwoman Morley wants to know who profits from sales of ride tickets/wristbands – she is also concerned about liability and insurance with the rides/bounce houses etc. Councilman Calvi asked for a price structure for a band, 5 rides and vendors so we can present it during our budget meetings. Mayor Martinez said this would be a Fall event but others inquired as to where everyone will park/who will attend if everyone has sports that weekend? Mayor will e-mail for a price quote and table this until next workshop.

Discussion – Land Use Ordinance Change – Councilman Piccirillo stated he had a conversation with a business owner who would like the Land Use Ordinance changed so it does not restrict him from having a secondary business that is not a convenience store at his gas station (143-5) Mayor stated it needs to be clearly defined- egs. we can't say no to a bike shop and yes to a stationery store – it has to be something quick and easy and we need to take parking into consideration. Unfortunately, Council stated the owner did not build the gas station correctly to begin with being that they crossed the lot lines, canopy was built in the wrong place etc. Due to his own fault, he can no longer separate the lots … they could have had 2 separate lots and businesses but not with how he built it – if it was done properly to begin with, we wouldn't have this issue. Council members stated we were in litigation for a long time with this property. It was advised that any request for changes go through the Planning Board- he will need to apply for variances.

Discussion – Museum Members – Councilman Meier once again expressed the Museums concern to increase their Board members. Council and Mr. Lampmann asked if it was only due to needing key holders and suggested

changing the by-laws. Mr. Meier said it's a combination of covering weekend hours, meetings and the key holders. This was tabled again until the next meeting when hopefully a museum member will attend to further explain.

Discussion – Salary Ordinance Review – Brandi Greco presented a Salary Ordinance that increases the cap amount on the Grade C employee structure. Council President Verdonik stressed the importance of this as it would allow the BA to receive a raise since he has not in over 5 years. All Council agreed and it will be formally introduced at our next meeting.

Discussion – Police Main St. – Mr. Lampmann said the Butler PD is looking to do a PBA Car Show on Main St from Park Place to Manning Ave. from 10am-3pm on a Sunday in late Spring early Summer. All costs will be absorbed by the event, not the Borough (traffic control overtime, set-up, clean-up) Mayor and Council all approve.

<u>NEW BUSINESS</u> – Brandi Greco announced this years Gran Fondo Bike Event will take place on June 2nd Councilwoman Morley asked that we stress the importance of not using the downtown business parking spots for those staying for the duration of the event. Make sure they park where they are supposed to and use the shuttles provided!

OPEN PUBLIC DISCUSSION

Mayor Martinez requested that we go to Open Public Discussion at this time and go into Closed Session afterwards so that those in attendance do not have to wait for that. He then opened the meeting to the public.

Linda Bennet Tomaskovic from 148 Vreeland Ave in Bloomingdale, Co-founder of BBCO Toy Drive, came forward to highlight some of the people and programs they have raised money for. She informed us and requested our help in spreading the word regarding fundraisers for the VFW. She said it is urgent to raise money for needed repairs after the recent flooding at their Post. The first one is a dine to donate at Tastefully British on February 26th. They are also working with Magpie Bakery on an American Flag cookie fundraiser as well as a Organizing a Beefsteak. She also said she likes our idea of the Butler Day as she is an organizer of the Sloane Park Festival. It will be held on a weekend in June so we don't overlap it.

BOROUGH OF BUTLER RESOLUTION 2024-27



WHEREAS, on November 3, 2020, the Marijuana Legalization Amendment was approved by voters in New Jersey, which legalized the possession and use of cannabis for residents twenty-one years of age or older; and

WHEREAS, on February 22, 2021, Governor Phil Murphy signed into law the New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act ("CREAMM Act"), which established the personal-use cannabis program in the State of New Jersey; and

WHEREAS, the Borough of Butler supports the safe and appropriate siting of cannabis businesses where such facilities are permitted pursuant to Ordinance 2021-15, Ordinance 2021-16 and Ordinance 2023 -10 (the "Ordinances"), to the extent consistent with applicable state and local statutes, rules, regulations, and ordinances; and

WHEREAS, the Ordinances permit the operation of Class 5 licensees within the Borough of Butler; and

WHEREAS, the Ordinances limit the number of Class 5 licensees to three (3) that may be licensed to operate within the Borough of Butler; and

WHEREAS, certain property exists within the Borough of Butler that is suitable to be developed with facilities for the operation of a Class 5 retail dispensary; and

WHEREAS, the Borough Council of the Borough of Butler hereby join the CREAMM Act's initiative, and support and endorse BWell Holdings NJ Inc.'s application for state licensure by the State of New Jersey Cannabis Regulatory Commission ("CRC") to operate a facility for Class 5 retail operations on premises located at 1331-1333 Route 23 South within the Borough of Butler.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Butler, County of Morris, State of New Jersey, as follows:

- 1. The Borough of Butler finds that it is important to provide for and protect the health and welfare of the citizens of the Borough of Butler, County of Morris, State of New Jersey, consistent with the CREAMM Act, N.J.S.A. § 24:6I-31 et seq.
- 2. As such, the Borough of Butler hereby supports the initiative taken by BWell Holdings NJ Inc. to operate a facility for Class 5 Cannabis operations (to the extent permitted by state law) within the Borough of Butler's boundaries, particularly at 1331-1333 Route 23 South, subject to, and in accordance with, all applicable ordinances.
- 3. The Borough of Butler has authorized the operation of Class 5 Cannabis licensees within the Borough, and the Borough of Butler does limit the number of licensed cannabis businesses that may operate within the Borough to three (3)—and therefore, the issuance of a Class 5 license to BWell Holdings NJ Inc. will not exceed the limit imposed by the Borough of Butler on the number of licensed cannabis businesses.

RESOLUTION AUTHORIZING THE LEASE OF CERTAIN OFFICE SPACE IN BOROUGH HALL TO THE PEQUANNOCK RIVER BASIN REGIONAL SEWERAGE AUTHORITY
