WORKSHOP MEETING OCTOBER 4, 2011 7PM 1

The Workshop Meeting of the Borough of Butler Mayor and Council was opened by Mayor Alviene who indicated that the meeting was being held in compliance with the Open Public Meetings Act having been duly advertised and posted in Borough Hall.

ROLL CALL

PRESENT: Council President Edwin Vath, Councilman Robert Fox, Councilman Stephen Regis, Councilman Raymond Verdonik, Councilman Robert Meier and Councilwoman Judith Woop ABSENT: Mayor Robert W. Alviene

ALSO PRESENT: J. Lampmann, Borough Administrator; R. Oostdyk, from the Office of the Borough Attorney and M. O'Keefe, Borough Clerk

Councilman Regis made a motion to excuse Mayor Alviene's absence, second by Councilman Fox All in favor.

R 2011-100 CHANGE ORDER BARTHOLDI AVENUE IMPROVEMENTS

Mr. Lampmann explained that the original project was extended to include the area up to Washington Street; at the request of the fire chief an additional fire hydrant was installed in the area of Saint Anthony's school and Church; the new hydrant will provide better coverage in the event of a fire. The additional work resulted in an increase of \$21,518.00, bringing the total contract cost to \$419,584.00; monies are available in the Capital budget to cover this increase.

Councilman Fox noted that this was the perfect time for the extension of the project as the road was open; the contractors were there this kept costs contained. Councilman Verdonik concurred noting that additional costs would accrue if the work were deferred to a future date. The Council concurred regarding the timing and noted water pressure would increase in the area because of this project.

<u>DISCUSSION REGARDING FEE INCREASES FOR CERTAIN FEES CHARGED BY THE</u> BOROUGH

In the continuation of a discussion held at the September 6, 2011 Workshop regarding the fees for liquor licensing, after additional research it was decided that the increase be limited to 10% which equals \$0.47 a day. Councilman Regis noted that a 10% increase is better for the licensees than a 20% increase.

The ordinance introducing this and other fee increases will be introduced at the October 18, 2011 meeting. Increases will not be in effect until 2012.

OPEN PUBLIC DISCUSSION

Council President Vath opened the meeting to the Public to speak on any subject.

<u>Sandy Bruno</u>, <u>18 Cleary Avenue</u> noted that Struble Avenue is in horrendous shape and she would like to know when repairs are scheduled for this road.

Mr. Lampmann noted that the area has had three major water main breaks in the last five years; this has led to the current condition of the road, rather than expending any additional funds on road pavement when the water main required replacement the Borough has been setting aside funds for the replacement. After much negotiating the Council approved a developers agreement at the September 20, 2011 Council Meeting that will provide appropriate funding to do the water main replacement project. The water main to be replaced is from Morse Avenue up to Cleary Avenue, with a slight extension into Sanders Place. Since there is, a portion of both the Struble and Cleary Avenue water mains that do not connect, one of the issues will include the connection of these water mains. The project should take approximately two weeks, after that time the road will be skim coated with asphalt, depending on the timing of the project and its completion the road might or might not be paved prior to winter, depending on settlement of the trench.

<u>Peter Stagg, 6 Aten Court</u> noted that although the Department of Public Works does a very good job plowing roads, Struble Avenue has deteriorated so much that the work is required prior to winter. Mr. Stagg questioned the time frame for the installation of the new hi-tech internet read electric meters. Lastly, Mr. Stagg inquired as to the usage of internet over power lines.

<u>Michael Leibruder, 84 Summit Avenue</u> wanted to thank the Borough for the improvement in his water quality; he questioned his electric bill being \$971.38 he felt that was excessive, as he has one air conditioner in a single family home with his wife and himself living there. Mr. Leibruder provided his account number to Mr. Lampmann so the Borough may do meter testing.

Mr. Lampmann explained that he would have a meter test done on Mr. Leibruders meter. Regarding Mr. Stagg's inquiry about the new internet read electric meters the equipment is currently being installed at the substation; initially there will be a test section of approximately 50 meters to work out any problems that may exist. Once any issues that arise are resolved, then the mass changeover will take place. Additionally, the Borough did not want to shut one of the substations down during the peak usage periods that occur over the summer months. Mr. Lampmann noted that he had done some research into the viability of the internet over power lines, at this time it would not be feasible.

<u>Debbie Sammon, 80 Summit Avenue</u> asked if the current 8-week recreation program could be extended an additional three weeks, until the school year begins which would extend the program through the end of August. . Ms. Sammon noted that she had to find childcare for the three-week period prior to the start of the school year and she felt that this would benefit other families in need of extended day care.

Council President Vath noted that he is a member of the Recreation Committee; he will bring the issue to the Committee
