DISCUSSION:

BUTLER DAY

Shelli Taggart and Robert Soules of the Recreation Commission provided a schedule and updated report on the event, noting the cancellation of the early events. The vendor fair would open for business at 3:00 p.m., with setup beginning at 1:00 p.m., currently 19 vendors have signed up, pending Council, and Board of Education approval. Mr. Soules noted he had a meeting with Fire Official Westdyk and Mr. Lampmann regarding buffer zones for the fireworks, the location chosen is acceptable for the fireworks. Mayor Alviene expressed concerns regarding insurance for the event; Mr. Lampmann noted that the fireworks vendor has all the appropriate insurance and the event is considered a Borough event. He also noted that all food vendors who cook on premises using propane would require inspection by the Fire Official on the day of the event, additionally; permits from the Board of Health would be required. responsibility electrical usage costs incurred and what would be the location of the electrical hookups. Mr. Lampmann noted that the Borough would require a plan detailing vendors requiring electrical access as supply might not be as great as the need. Ms. Taggart explained that she requested the vendors to provide their own power sources however if they are unable to do this the application could be denied. She did note many of the vendors might only be handing out informational pamphlets. Carnival games would be free to all who wish to play, no games of chance will be run by the Recreation Commission. Councilman Verdonik asked about the locations of the vendors, noting that the streets located near the school would remain open, also who is providing security for the event, and how will disorderly persons be handled. Councilman Verdonik and Mr. Lampmann noted that the Butler Police would need to be on site, and the Fire Chief should be involved, as he has access to the fire police. Councilman Fox has concerns about parking; Ms. Taggart noted that she had approached Saint Anthony's and Butler Methodist Church regarding use of their parking lots in exchange for booths at the event. Councilman Verdonik asked if the Board of Education had already approved field usage, noting that it is his understanding that Memorial Field will not be used; however, what is the status on the other fields. He is happy that the events have been scaled down, as this reduces the amount of problems that may occur. Ms. Taggart explained that it is her hope that the Board of Education approves the use of the fields this evening. Regarding trash the vendors would be required to submit a \$200.00 deposit for any clean up or additional costs, the deposit is if all the terms and conditions are met.

Mayor Alviene did an informal poll of the Council and all were in favor of the event, Council President Vath noted that this event was a long time coming.

2013 BUDGET Mr. Kozimor noted that all budget meetings have been held, he provided the Mayor and Council a preliminary budget, requesting that any questions regarding this be directed to either Mr. Lampmann or himself. The Budget will be ready for introduction at the March 19, 2013 Council meeting. The Mayor and Council wanted to thank the Department heads and both Mr. Lampmann and Mr. Kozimor for their hard work to bring this budget in under the 2% CAP while not cutting any services.

It was discussed that in the body of the lease, language could be included that would allow the Borough to assume either a portion or the entire electric bill in exchange for certain services. Additionally, the lease should be auto renewing for a fixed length of time. As a condition of the lease they would need to provide proof of continued non-profit status, in addition they must provide proof of insurance to the Borough Clerk.

Mayor Alviene noted that a letter was sent thanking Mr. Thomas Warden of All State Oil Recovery Co., for his assistance during Hurricane Sandy cleanup efforts.

Mayor Alviene opened the meeting to the public at this time>

<u>Christine Argenio, 1 Richard Court</u> is here this evening to inform the Mayor and Council that with the installation of the new sidewalks on Myrtle Avenue she is unable to remove the snow from the sidewalks in front of her home. She has broken her snow blower on numerous occasions, trying to remove these "boulders" of snow from her sidewalk. Ms. Argenio feels that these sidewalks have changed her living situation, and has created an additional cost for snow removal, noting that she is not the only homeowner affected by the new sidewalks. Mr. Lampmann explained that when the snowfall is not heavy a smaller truck would be used for plowing, however, in a larger storm the larger truck would be used, when the snow is heavy it is difficult for the person plowing to delineate between the street and the sidewalk. Ms. Argenio asked for reimbursement from the Borough for her sidewalks, as they have created a hardship and an additional expense. The Council understands and sympathizes with Ms. Argenio however; the Council cannot set a precedent by waiving the cost of the sidewalks. Mayor Alviene noted that each affected homeowner throughout the Borough would ask for the same treatment and this would be a fiscal nightmare for the Borough.
