After discussion it was determined that no action will be taken at this time regarding.

Placement of a Historic Marker at the Site of the Butternut Tree form the Historic Mead Farm on Kiel Avenue

Russell Hannah, 9 Standish Ln, Kinnelon

Mr. Hannah explained that the tree in question is not as old as the marker states; the tree is a hybrid butternut tree that is a cross between a Japanese Walnut and an American White Walnut tree. Pure butternut trees have a short life expectancy; therefore, this tree cannot be that old. Mr. Hannah had DNA testing done at Perdue University confirming that this is a hybrid tree. He would like the marker adjusted to identify the location as the site of the historic Mead Farm; he cannot apply, as it must be authorized by either the Mayor and Council or the Historic Society, he is here this evening to ask for Butler's support on this matter. The Mayor and Council requested correspondence with the Kinnelon Historic Society for their opinion on this matter. Additionally, Mayor Alviene would like Mr. Hannah to provide the proof he has to the Mayor and Council.
