REOUEST

Request from Butler Methodist Church to use Butler Park Ecumenical Cross Walk on Friday, April 18, 2014 and Sunday, April 20, 2014 for Easter Sunrise Service

Ms. O'Keefe explained that this is a yearly event, should there be hazardous conditions in the park the Borough might withdraw permission. As the event days approach, reevaluation of the situation will be done if necessary for safety reasons.

DISCUSSION:

Memorial Day Parade

Acting Chief Chimento suggested that perhaps the Memorial Day Parade should begin in Bloomingdale and conclude in Butler, with Butler being the host this year. This alleviates the length of time the railroad is stopped. The Mayor and Council concurred with this change.

Saint Anthony's Avenue, Right of Way

Mr. Lampmann explained that Matthew Maher, a resident contacted him regarding ownership of Saint Anthony's Avenue, which is located off Boonton Avenue and appears as a road on the tax maps. An inspection of the area by the Borough surveyor was performed and he concurs with the findings provided by Mr. Maher. Mr. Oostdyk in detailing the procedure for the Borough to take possession of the road starts with determining if the road was ever dedicated, a decision is required as to whether or not the Borough needs this land, or will it be vacated, or accepted. Mr. Lampmann explained that in speaking with Mr. Becker, former DPW Superintendent stated the Borough has not maintained that property during his 34 years of service to the Borough. Mr. Oostdyk noted that it is clear it has not been accepted since the Borough has not maintained this property. The fact that it appears on the maps probably tells us that there has been a dedication of the road; however, just because it appears on a map does not make it a public road. Although in the future, it might become a public road there are a number of factors that require need to be

addressed prior to acceptance by the Borough. The Borough will research this further; Mr. Lampmann will contact Mr. Maher as more information becomes available.

Mr. Lampmann noted that he has been working with the Mayor regarding appointments to the Office of Emergency Management. He has spoken with the following individuals and they have agreed to the serve in the Office of Emergency Management: Acting Lieutenant Scott Ricker has agreed to become Coordinator for the Office of Emergency Management, Brandi Smith-Greco will handle public information; Chief John Ryan will handle Fire Rescue, Acting Chief Chimento will handle the Police portion. Regarding the remaining open positions, he will continue to work with Mayor Alviene to fill the remaining positions; official appointments will be made at a public meeting in the future. Mr. Lampmann explained that as he is working on the Emergency Management Plan, he is finding that you need to have the positions filled; he would like to work in conjunction with the coordinator. Mayor Alviene noted this will provide Acting Lt. Ricker a chance to prove himself and will reflect on his new position; this will also bring the Borough into compliance regarding Emergency Management.

Mr. Lampmann noted that at the March 18, meeting an ordinance will be introduced detailing the new structure of the Police department. Mr. Oostdyk explained that the ordinance must reflect the current structure; amendments to the ordinance are required as changes occur.

Councilman McNear brought up an issue that was discussed at the Board of Health meeting regarding massage parlors. Mr. Oostdyk clarified that the Borough no longer has an ordinance regarding massage parlors it was deleted last year. The enforcing agent would be the Health Officer, as licenses are required for each massage therapist; individuals are not permitted to share a license.

WHEREAS, the PPANJ has adopted a risk management policy for adoption by each member of the PPANJ that participates in the PJM markets;

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED by the Mayor and Council of the Borough of Butler that James P. Lampmann is hereby authorized to act as certifying officer for the purpose of submitting the PJM Officer Certification Form and that the attached risk management policy, included and made part hereof, is hereby adopted.
