The Workshop Meeting of the Borough of Butler Mayor and Council was opened by Mayor Alviene who indicated that the meeting was being held in compliance with the Open Public Meetings Act having been duly advertised and posted in Borough Hall.

DISCUSSION

Carey Avenue Water Main Replacement – Mr. Lampmann explained that when the bid goes out, it will not be for the entire project, the Borough is trying to conserve some funding to repave the entire road with the \$80,000 grant funding available. The bid will be for the excavation portion of the project only, with Borough employees doing the other portion of the project. The work performed by the Borough Employees will serve as an educational opportunity for our newer employees in the Department of Public Works they will learn about doing house connections, setting pipes in a non-emergency as opposed to during a water main break. Based on the cost projections it appears that the job can be done for approximately one-half the price using Borough employees. Quotes have been received from the contractors for the excavation portion of the job; we are awaiting quotes on materials.

2014 Road Repaving – Mr. Lampmann provided the Mayor and Council with a listing of 2014 Preliminary Paving Projects (attached), discussion ensued regarding which roads are in the greatest need of paving. Council President Vath noted that there is a section of Walnut Lane that needs some work done to level the road, when the plows go through they are taking a layer of asphalt with them. As not all roads listed may be done with, the funding available Mr. Lampmann noted that the only other option to fund all of these road projects would be to bond and the Mayor and Council were unanimous that bonding is not an option. Mr. Lampmann noted that work done on Walnut Lane would be torn up next year when the road is completely repaved. Mr. Lampmann noted that there are may be other options that can be explored to stretch the funding however; this would need to be after the chosen projects are awarded. Projects chosen are Boonton Avenue Trench Repair, Carey Avenue, Cedar Street from Center to Valley Road, Leonard Road, Sunset Avenue from Leonard Road to the Bromat Property and Sunset Avenue from Leonard Road to Terrace Avenue.
