The Workshop Meeting of the Borough of Butler Mayor and Council was opened by Mayor Alviene who indicated that the meeting was being held in compliance with the Open Public Meetings Act having been duly advertised and posted in Borough Hall.

## **DISCUSSION:**

Discussion of the 2015 Municipal Budget was conducted with the introduction scheduled for the March 17, 2015 meeting with the adoption at the April 21, 2015 meeting. Mr. Kozimor explained that the budget underwent a careful examination to find any additional savings to the taxpayers. The budget as it stands now would show an increase to the average homeowner of \$51.33; this includes increases in the library assessment. The main forces driving the increase in the budget are increases in health insurance costs, new garbage contract that increased and Pequannock River Basin Regional Sewerage Authority costs have increased. Line items are relatively flat on the operating side, minor increases were included for some departments, salary and wages have remained at the 2% increase. Capital expenditures increased by \$25,000, snow removal has had an impact on the budget. While this increase covers the Municipal portion of the budget, the schoolboard has not yet finalized their budget. No services cuts are in this budget, and the projected municipal increase is still reasonable. Discussion on Capital requests will take place at the April workshop meeting. Major items include road improvement programs, continued improvements at the water treatment facility, purchase of a vehicle for the Electric Utility, installation of a generator at the Municipal Building. Mr. Lampmann noted that the Capital improvement plan costs as presented are included in this budget, with no increases in taxes or the utility costs if all plans go as projected. Mr. Lampmann additionally explained that we are waiting for Bloomingdale to receive the permits to connect to the water supply piping in Butler. The permit request includes changes to the stream path in Sloane Park; at this time, they are trying to separate the two applications.

Councilman McNear asked if there were any major problems with the Boil Water alert issued, Mr. Lampmann explained that once the Nixle alert went out, the 911 system, Water Treatment Plant and his phone were inundated with calls. He also received calls from several major news outlets, who were under the impression that it was a water main break and wanted to send a camera crew to film the problem, he explained that it is a valve in the floor, additionally they thought a greater number of customers were without water, they were misinformed. Residents were well informed, sampling as per DEP standards has been completed and the Borough is waiting for the DEP response so that we can discontinue the Boil Water Alert. Keith Smith our Water Treatment Operator was excellent in his response and in coordinating with the DEP. The valve itself was not broken the valve company will be inspecting the valve tomorrow. All notifications require DEP approval prior to distribution.
