#### **Discussion – Firearms Ordinance Amendment Request from Chief Chimento**

Mayor Alviene polled the Council regarding the addition to the Firearms Ordinance the consensus was that the Borough is no longer as sparsely populated to allow for target practice of bows and arrows, compound bows, crossbows and ballistic slingshots. The amendment to the ordinance will be prepared for introduction at the September 15, 2020 Regular Council meeting.

### Discussion – Adding Butler Arms Parking Area to the Borough Code to allow for enforcement of Title 39

Discussion ensued regarding this request; this would be done at request of the owner, as there are various criteria that must be met before it may be added to the Borough Code. Councilman Fox noted that parking has always been problematic since the buildings were built. Currently the Fire Official may enforce illegal parking in a fire zone. Should the owner request Title 39 be enforced it will be revisited at that time.

#### Discussion – An Ordinance Amending Chapter 180 Property Maintenance – Unlawful Conditions

Mr. Lampmann explained that the purpose of this amendment is when people use their yards as a storage facility. Mayor Alviene asked if this was covered by the no bail law, Mr. Oostdyk explained that it would be covered under that. The purpose of this ordinance is to give the Zoning Officer a greater ability to write a summons for an unsightly mess on someone's property. The ordinance will be introduced at the September 15, 2020, Regular Council meeting.

#### Appointing Dana Croker to the Butler Board of Health for the unexpired term of Sandra Alviene.

The Mayor polled the Council and they concurred that Ms. Croker would be an asset to the Board of Health. The Borough Clerk will contact Ms. Croker regarding her appointment and the oath of office.

### **Discussion - Request for Handicap Parking Space – 5 Cook Street**

Mr. Edland had contacted the Borough Clerk in 2019, as no response was received until Mrs. Edland had contacted her approximately two weeks prior. The Mayor and the Council asked that more information

Mr. Lampmann explained that Mr. Westdyk the current Fire Inspector is retiring and a replacement is needed, he contacted Bloomingdale and was able to work out an Interlocal Services Agreement for the provision of Fire Inspection Services. This would be advantageous to the residents of the Borough. Mr. Lampmann will have further discussion regarding a 2% increase in 2021 as the contract only covers three months in 2020.
