Discussion – Butler Museum Committee

Paul Bastante – Chair of the Butler Museum wanted to thank the Mayor and Council for their support. He is present this evening to ask for support from the Mayor and Council to host a toy drive as the Toys for Tots train will not be operating due to the current restrictions of COVID-19. Mr. Bastante has reached out to the various community organizations and they will assist in providing families who can benefit from the donations. He also noted that there is an organization Wheel of Dreams in the Borough that wants to donate contractor services to the Borough by decorating the Museum for the upcoming holiday season. The contractor will leave a container so toys may be dropped off, and people may take pictures with the decorations in the background. The museum will be open to accept toys; distribution will be done working with the various community organizations to the appropriate families. Mayor Alviene asked what the guidelines would be for distribution of the toys as far as safety is concerned. Mr. Bastante explained that the Religious and Community Organizations would be distribute them. The Museum will strictly be a collection point. Mr. Bastante will provide the Mayor and Council plans for the drop off and distribution of the toys.




