**Before completing the Tree Removal Permit Application, please consider the following impacts on your lot as well as surrounding lots:**

- Does the removal of tree(s) impact the soil erosion and drainage of the surrounding area?
- Does the removal of the tree(s) impact other plantings (i.e., shade plants will get too much sun as a result of tree removal)?
- Does the removal of tree(s) impact privacy/screening?
- If the tree is on or near the property line, we strongly suggest informing your neighbor about your plans to remove the tree(s).
- If replacement tree(s) are required, they must be planted within six (6) months after tree removal.

**Ordinance Guidelines (Pursuant to Borough Code Chapter 220):**

- A tree permit is required for the removal of all trees six (6) inches in diameter or greater.
- Property owners shall be allowed to remove four (4) trees (as defined below) less than sixteen (16) inches in diameter within any five (5) year period, BUT THEY MUST STILL OBTAIN A PERMIT.
- A tree is defined as any deciduous or coniferous species which has a diameter of 6 inches (19 inches in circumference) or greater, measured at a point of four and one half (4 ½) feet above ground level on the downhill side of the tree.
- Any removal of a tree without a permit may result in a fine as defined by the municipal body and tree replacements as described in the Ordinance.
- Tree Removal Permit is good for twelve (12) months from date issued
- For a list of NON-approved replacement trees, see Borough Code Chapter 220 Section 5
