MINUTES

New Jersey Public Power Authority

January 18, 2024

The annual reorganization meeting held at the Borough of South River Municipal Building, 48 Washington Street, South River NJ 08882 and via conference call was called to order at 10:31 AM by Jim Borowski, Authority President.

In addition to Borowski, representing the Borough of Lavallette, the following were present for the meeting: Jim Lampmann for the Borough of Butler; Jim Burnet for the Borough of Madison; Fred Carr for the Borough of Milltown; Kathy Smick for the Borough of Pemberton; Paul Longo for the Borough of Park Ridge; Chris Vaz for the Borough of Seaside Heights; Joe Zanga for the Borough of South River. Also present was: Brian Vayda Executive Director for the Association; Art Londensky for the Borough of South River; Mike Osbourne for Sussex Rural Electric Coop. and Chrissy Mahler for the Borough of Madison. Vineland was not present for the meeting.

Borowski opened the meeting with the reading of the required statement: "Notice of this meeting was originally published in the Star-Ledger on February 6, 2023 and displayed by Authority members in their municipal offices or on their websites.

Minutes of the meeting of the Regular Meeting of October 12, 2023, and the special meeting of November 8, 2023 were set for approval. Lampmann offered a motion to approve. Zanga offered a second. The voice vote was unanimous.

Claims for the period ending January 31, 2023 in the amount of \$89,942.20 were set for approval. A motion was offered by Vaz with a second by Lampmann. The voice vote was unanimous.

The **Treasurer's Report** for the period ending January 31, 2023 showed year to date Net Income of \$26,076.12 with revenues of \$159.511.10 and expenses of \$133,434,98. The balance sheet showed a cash balance of \$238,065.12 at Lakeland Bank and \$104,340.11 at NJ Cash Management fund, and accounts payable of \$0. Lampmann made a motion to accept the report. Longo offered a second. The voice vote was unanimous.

The **executive director's 2023/2024 annual report and outlook** were delivered in advance of the meeting. Vayda gave a summary of the report and some of the issues facing our members in the PJM market. The executive director's reports were accepted following a motion offered by Zanga. Longo offered a second. The voice vote was unanimous.

A list of those to be considered for as **Commissioners** for 2024 was delivered to the secretary and all members in advance of the meeting. Borowski mentioned that each member system may nominate one Commissioner and one alternate. Borowski made a motion to cast a unanimous ballot for Commissioners: **Jim Lampmann of Butler**, **Jim Borowski of Lavallette**, **Jim Burnet**

of Madison, Fred Carr of Milltown, Paul Longo of Park Ridge, Kathy Smick of Pemberton, Christopher Vaz of Seaside Heights, Joe Zanga of South River and John Lillie of Vineland. Zanga offered a second. The voice vote was unanimous.

Vayda reported on behalf of the Administrative Committee. The committee recommended that the following slate of offices be elected: Jim Borowski for President; Joe Zanga for Vice-President; Fred Carr as Secretary; and Jim Lampmann as Treasurer. Borowski opened the floor for nominations and after hearing none, the floor was closed. Vaz offered a motion to place the following names in nomination as officers for 2024: Jim Borowski for President; Joe Zanga for Vice-President; Jeanette Larrison as Secretary; and Jim Lampmann as Treasurer that the nominations be closed, and a unanimous ballot be cast. Smick offered a second to the motion.

A roll call of the votes ensued.
