Richard Clemack, Esq. resumed the presentation from the previous meeting for the applicant.

Traffic Engineer Connor Hughes, Dynamic Traffic LLC, 245 Main Street, Chester was sworn in and presented his credentials to the Board.

Accepting him as a traffic expert: Brown Second: Finelli All in favor

Per the Board's request Mr. Hughes had presented his report ten days prior to the meeting. He then discussed the report. Trip generations 6 total in the AM rush hour and 8 total in the PM rush hour.

Based on the current tenants the traffic use is greater than what the proposed use will generate per Table III on page 3 of his report.

Table IV on page 4 indicates that the proposed use will account for only 1% of the traffic on Main Street.

He answered the JDA report prepared by Mr. Gary Anderson:

#9 Garbage removal. He addressed the concerns the Board had regarding the ability of the garbage contractor to be able to adequately empty the dumpster with the proposed design.

#14 Site Triangle. 200 feet required.

#16 Proposed Signage. The warning signs for the public to be aware of exiting vehicles will be provided to the satisfaction of the Board Engineer.

The 2018 study shows the traffic counts to be higher than they are today - post Covid.

Architect Scott Monro suggested restrict designated parking to the front part of the garage and designate visitor parking to the rear and possibly putting in curbs to protect pedestrians.

Open to the public. No one came forward.

Close public portion: Brown Second: Finelli All in favor.

Kimberly Sedlacek, owner, 103 Arch Street, Butler, was sworn in.

She gave a history of the building and her family's involvement in it since 2003. She loves the history of the old movie theater and was hoping for a use that would maintain its architectural history.

Currently they have a number of commercial/self-storage tenants in the building. There is no on-site parking for the commercial or the three residential tenants currently in the building.

It is very difficult to conform to the CBD zone requirements when located on a residential street.
