RESOLUTION TO SUPPORT PUBLISHING LEGAL NOTICES ON OFFICIAL GOVERNMENT WEBSITES

WHEREAS, the sunset provision of March 1, 2025 imposed under P.L. 2024 c. 106 is fast approaching in what was a temporary solution that allowed local governments to comply with the public notice requirements under the law in time for annual reorganization meetings in January; and,

WHEREAS, local government officials serve as the stewards of property taxpayer dollars and should no longer be required to subsidize the newspaper industry with revenues collected from publishing legal notices in the press; and,

WHEREAS, long before NJ Advanced Media's announcement that it was terminating daily print publications in January of 2025, local government officials found it increasingly difficult to comply with the public notice requirements under the law as the media has become almost exclusively digitized and struggled to retain staff, resources, and publications; and,

WHEREAS, legislation that will authorize local governments to publish legal notices on a local government's official website will streamline an antiquated and overly burdensome process and save valuable time, resources and property taxpayer dollars; and,

NOW, THEREFORE, BE IT RESOLVED that the Borough Council of the Borough of Butler, County of Morris, State of New Jersey does in fact, hereby urge state leaders to pass legislation that will authorize municipalities, counties, school districts, and all local governments to publish legal notices in a clear, transparent, and timely manner on a local government's official website.

BE IT FURTHER RESOLVED that a copy of this Resolution shall be sent to Governor Phil Murphy, Senate President Nicholas Scutari, Speaker of the General Assembly Craig Coughlin, Senator Anthony Bucco, Assemblymembers Christian Barranco and Aura Dunn, and the NJ State League of Municipalities.

RESOLUTION OF THE BOROUGH OF BUTLER, AUTHORIZING THE AWARD OF A CONTRACT WITH LEW ENVIRONMENTAL SERVICES LLC FOR THE MANAGEMENT OF LEAD TESTING FOR CERTAIN RENTAL UNITS

WHEREAS, the Borough of Butler is required to comply with the Lead-Based Paint Inspection in rental dwellings law N.J.A.C. 5:28A, formally P.L. 2021, c.182; and

WHEREAS, the law imposes an obligation on municipalities to perform or hire a certified lead evaluation contractor to perform inspections of certain single-family, two family, and multiple rental dwellings, built before 1978, for lead-based paint hazards every three years or upon tenant turnover where there is no valid lead-safe certification; and

WHEREAS, the New Jersey Department of Community Affairs (NJDCA) certifies lead evaluation contractors pursuant to N.J.A.C. 5:17; and

WHEREAS, the Borough wishes to retain LEW Environmental Services LLC, who has been certified by the NJDCA pursuant to N.J.A.C. 5:17, to perform such services; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Butler, in the County of Morris, and State of New Jersey, as follows:

Section 1. The Mayor, Borough Administrator, and Borough Clerk are hereby authorized and directed to execute a contract with LEW Environmental Services LLC for the management of lead testing for certain rental units.

Section 2. LEW Environmental Services LLC shall provide services related to the management of lead testing of rental units in the Borough of Butler as set forth in proposal 3327, dated November 27, 2024.

Section 3. A notice of this action shall be printed once in the legal newspaper of the Borough of Butler as required by law.

Section 4. A copy of this Resolution shall be provided to LEW Environmental Services LLC, 181 US Hwy 46, Mine Hill, NJ 07803, for their information and guidance.
