Discussion – Towing application from Factory Auto Body- Councilman Fox wanted to confirm that they were in our service parameters and had suitable equipment to handle our callouts. Mr. Lampmann explained the yard is right on Route 23 just over the Butler border and reminded them we still have two other approved towers. This third one was requested by the BPD due to low reliability from one of our other two. Neighboring towns use this company with success. We do not want to get into a bind if we encounter a large accident and/or extreme winter weather.

Mr. Lampmann stated he had a few additional agenda items to go over, specifically budget related. He summarized the budget and gave an overview of Capital requests for the Council to consider including items for Police, Fire, Electric, Water, Building and Grounds, paving and water plant design. He explained the per household impact and highlighted where our biggest increases were: trash, gasoline, natural gas and benefits. He is proud to report the water budget is in the black for the first time in many years.

Mr. Lampmann also stated the trash contract is still in review with our attorneys for some minor language changes. Mr. Lampmann requested approval to move ahead and execute the contract once received back. All were in agreement. The Borough is waiting on 62 dumpsters and hopes to receive them by April 1st.
